Policy Issues

- Legislative bill LB 565, Nebraska Land Information System Program Act did not pass.
- Public Records Law and Geospatial Data did not pass. This bill referred back to local government requiring entities to sign an agreement not to charge for data given to them.
- Metadata: All state agencies and entities that receive state funding used, directly or indirectly, for geospatial data development or maintenance shall ensure that geospatial data it collects, produces, maintains, or purchases and which is used for policy development, implementation, or compliance review is documented with metadata compliant with the latest version of the Federal Geographic Data Committee (FGDC) Content Standards for Digital Geospatial Metadata. This will also enable data sharing within agency and between agencies.
 - RAMONA is a tool to aid with inventory of GIS datasets and a strong beginning to metadata. <http://ne.gisinventory.net> Once you create the initial profile for this program, data entry speeds along.
 - Department of Natural Resources has a metadata lite data entry page and a FGDC metadata compliant upload page at <http://www.dnr.ne.gov/databank/geospatial.html>
