Call to Order

Meeting called to order at 9:03am by Mike P. No changes to the Agenda.

Review & approve previous meeting's minutes

Norman S. moved to approve the July meeting minutes. Eric K. seconded. All approved. Motion passed.

Financial report

Income/Expenditures

Total currently in checking is \$44,756. No income. There was one expense of \$26 for conference calling.

There was discussion on the possibility of replacing the old poster boards. Eric K. has started to review information on some of the available portable displays. However, most of the displays Eric has reviewed have been fairly expensive. Ideas for making some type of portable display boards were also talked about. There will be further review to look at other options and costs of buying versus possibly making some kind of display boards.

The board discussed moving some money from checking to a short-term CD or money market account. Eric K. moved to authorize that \$30-35,000 may be moved over to a short-term CD or money market account. Jeff M. seconded. All approved. Motion passed.

Nebraska GIS Council

No meeting held. Larry Zink reported that Dan Pfeffer is working on a Street Centerline project for a Pilot Area (5 counties around the urban core area). The Public Service Commission is taking the lead on Broadband availability mapping. Money was acquired from State partners to buy the 4th band of NAIP imagery (1meter) that was flown this summer.

Scholarship

Nothing more has been worked out since that last meeting. The board discussed ideas on how to get the scholarship program started. There is work still to do on how to set up, who to talk to, where to go, etc.

Other Business

All approved. Motion passed.
